COUNCIL 9709 CHRISTMAS PARTY GIVES MORE THAN IT RECEIVES

KoC Council 9709's annual Christmas party, held on Dec. 3 at The Heritage, was a huge success, with 115 Knights and their families in attendance. Thanks to the planning and preparation of Tom and Elaine Dupree, the excellent food and the festive music provided by Bob Gottlief everyone had a wonderful time. And even more importantly, Brother Knights of Council 9709 and their families will brighten the Christmas season for at least 56 needy children in the Raleigh area this year. The "Toys for Tots" table at the 2006 Christmas party (photo right) was overflowing with generosity.

"At an average cost of between \$10-15 per gift, Brother Knights contributed well over \$500 to the U.S. Marine Corps' annual 'Toys for Tots' drive," said Grand Knight Dave Vogelpohl.

But the generosity did not stop there. Brother John Izzo's daughter, Megan, and her friend Emmalee Todd provided centerpieces for the 27 tables. They conducted a silent auction for the centerpieces at the end of the dinner and raised another \$221 for "Toys for Tots."

Donated toys included a variety of things for girls and boys ages four through perhaps 12. There were teddy bears and large building blocks for tots and Legos, dolls and trucks for the older set. There were even a football and a basketball for aspiring athletes.

The most popular gift was something called "Magic Glow Doodle Bear-Write with Light." Apparently, a child can write on the included teddy bear with "glow in the dark" ink. There were three of these. Unclear from the packaging was whether Mom could wash the ink off walls . . .

\$2,500 DONATION TO BE VOTED AT JAN. 9 BUSINESS MEETING

St. Francis Director of Operations Ben Whitehouse will make a presentation at the Jan. 9 meeting on the 2007 Capital Campaign prior to the vote.

Nominations will also be solicited and an election held for Chancellor at the Jan. 9 meeting. Grand Knight Dave Vogelpohl announced the resignation of Brother Dennis Kelleher from that position at the Dec. 4 meeting. Business meetings in 2007 will be held the first Tuesday of each month due to scheduling conflicts for the Gathering Room.

"Paying your dues is a fundamental responsibility of membership in the Knights of Columbus. These dues are a primary source of revenue to support our activities and programs," said Grand Knight Dave Vogelpohl. "Once you receive your notice, please pay your dues promptly by writing a check, payable to the Knights of Columbus, and send it to Financial Secretary Jerry Cucurullo whose return address appears on the envelope.


FROM THE GRAND KNIGHT:

NEWSLETTERS AVAILABLE ONLY VIA E-MAIL AS OF JANUARY 2007

The KoC Council 9709 newsletter will only be mailed out to Brother Knights who do not have e-mail beginning with the January 2007 newsletter. The decision to stop blanket mailing of the newsletter was made at the Nov. 27 Officers Meeting.

"The cost of producing and mailing out the newsletter is over \$100 per month," said Council 9709 Lecturer Dick Bridges, who also does the newsletter. "The officers felt that the \$1,200 per year devoted to producing and mailing out the newsletter could be better used elsewhere. Most Knights seem to prefer the color version that we e-mail for free directly to them, and the newsletter is also readily available on the website at www.kofc9709.org in .pdf format."

The suggestion at the July 10 Business Meeting to offer the membership the option of foregoing the paper version voluntarily in favor of the e-mail version only resulted in about 30 Knights asking that their names be pulled off the mailout list.

The .pdf format can be printed on any standard printer, should a paper copy be desired.

paid yearly per capita to the Supreme and State Councils, Catholic Advertising and liability insurance. Honorary Life Members (age 70 with 25 years of continuous membership) do not pay dues, and Honorary Members (age 65 and 25 years continuous membership) pay only \$10 per year.

In addition to dues, each bill contains a voluntary "Penny Per Day Per Knight" charge of \$3.65 for the State Catholic Charities Fund. Per a resolution adopted at the 1999 State Convention, this money is used in full each year to assist during a disaster or to aid a needy parish as determined by the state's three Bishops. Although this is a voluntary contribution, many brothers have donated much more than a penny per day. Whatever you can give, please include it in the same check as your dues payment.

"Finally, although dues are mandatory, any brother who is in financial need can request that his dues be waived by the Council. Please contact Financial Secretary Jerry Cucurullo or myself directly if paying the dues would be a burden," said Brother Vogelpohl. "We are more interested in keeping you as a Knight under such circumstances than contributing to your hardship."

BISHOP'S ANNUAL APPEAL FOR 2007 NEEDS KNIGHT VOLUNTEERS JAN. 6-7

Knights of Columbus Council 9709 will not be hosting a spaghetti dinner this year for the Bishop's Annual Appeal (BAA), but Brother Knights are still needed as volunteers at all Masses the weekend of Jan. 6-7.

This year St. Francis of Assisi Catholic Community will be conducting an "in-pew" appeal for pledges of support from parishioners. In order to lessen the burden on ushers at each Mass Jan. 6-7, Brother Knights will be needed to distribute pledge cards and pencils before Masses and later to collect pledge cards.

Six Knights per Mass are needed to arrive about 20 minutes ahead of each Mass to stock the pews. Brother Dennis Kelleher is coordinating this effort. Brother Knights able to assist him should contact him via e-mail at kelleherdl@aol.com and let him know at what Mass they would be willing to help.

"Bishop Burbidge is scheduled to celebrate the 5:30 p.m. Mass Saturday, Jan. 6, and the 9:30 a.m. Mass Sunday, Jan. 7, for this event. A strong and visible Knights' presence would be very appropriate and desirable for our Council," said Grand Knight Dave Vogelpohl.

St. Francis of Assisi Catholic Community has traditionally been the leading donor to the BAA in the diocese, and St. Francis' goal of \$350,000 this year out of the total Diocesan goal of \$4 million reflects a five percent increase over last year's goal. And, St. Francis usually reaches its goal with only about 30 percent of parishioners participating.

"The goal this year is to significantly increase participation as a parish," said Brother Kelleher. "That's why the 'in-pew' appeal is key. It is not how much we give; it is how many of us participate in this worthwhile fund drive that will define us as a parish in this Diocese of Raleigh."

The "in-pew" drive will be in addition to the normal mail out to parishioners that should be completed prior to the Jan. 6-7 weekend.

The BAA supports more than 20 agencies throughout the Diocese. Half goes to Catholic charities, and half goes to support of Diocesan-wide ecclesiastical programs such as Vocations and Lay Ministry Formation.
