The winning tickets will be drawn Saturday, May 3 at the State Convention in Asheville. Ticket purchasers do not need to be present to win, and winners will be notified directly by the State Council and printed on the back of next year's raffle tickets, just like this year's. Last year's winners were Delores Bode of Roxboro for the Alaskan cruise and Tammy Mulligan of High Point for the Hawaiian vacation.

The Grand Prize is a 7-10 day Alaskan Cruise for two, including airfare and \$700 cash. Second prize is a seven-night, six day, two-island Hawaiian vacation for two, including airfare, four nights on Waikiki, three nights on Maui, a voucher for a Polynesian Cultural Center Dinner/Show, roundtrip transfers from the Airport at Waikiki and a rental car on Maui. There are also five other consolation prizes, each of \$200 cash.

The \$5 purchase price of the ticket is not tax-deductible, and winners will need to pay applicable taxes, both federal and state, on winnings.



The items enumerated in the December and January newsletters under the "For the First Degree Knight" section came from a Knights of Columbus pamphlet produced in conjunction with the Knights of Columbus Insurance program. The money for many of those "Did You Know" items was contributed from the profits made

by Knights of Columbus Insurance.

## THREE VOTES FOR GENERAL FUNDS DISBURSEMENTS SET FOR MARCH 4 MEETING

Attendees at the March 4 business meeting will be asked to vote on three separate motions tabled at the Feb. 5 meeting for disbursement of General Fund monies. Any unbudgeted expenditure over \$200, according to the Council's By-Laws, must be made in a motion at one meeting and tabled for vote at the next business meeting.

At the Feb. 5 meeting, a motion was made to allow up to \$3,500 to be disbursed from the General Fund to cover outstanding expenses from the Council's 20<sup>th</sup> Anniversary Celebration Dinner on Jan. 26. Some \$2,025 in revenue with another \$60 still outstanding was generated for the event and deposited into the General Fund. Outstanding expenses remaining are \$3,286.48, which include: \$2,202.00 to the caterer, Michelle Cash; \$727.70 to DJ's Event Rentals; \$68.05 to Classic Party Rentals, \$118.53 to International Minute Press and \$170.20 for invitations and postage.

A check from the Fund for \$641.24 was issued to DJ's Event Rentals prior to the motion for using the Fund as a conduit for payment.

"Technically, payment should not have been made prior to Council approval of the motion to authorize the General Fund to make such disbursements. I take full responsibility for the error," said Grand Knight Mike Darrow. The Grand Knight also announced at the Feb. 5 meeting that revenues from future endeavors such as concession stand sales at Durham Bulls games, the Crèche Raffle tickets and revenues from the State Convention Raffle would be applied to the shortfall.

Two other motions were made and seconded at the Feb. 5 meeting that will require a vote March 4. Attendees at the March 4 meeting will be asked to vote on a motion to allow General Fund disbursements from the General Fund to be made commensurate with revenues deposited into the General Fund from Barbecue revenues for the April 12 event estimated to be \$9,080. Attendees will also be asked to approve a \$400 expenditure for eight bricks engraved with the names of the eight Council members who have died since the chartering of the Council to be installed at the Blessed Mary Grotto at the Father Price Council Compound.
