

RALEIGH LAMB AGENCIES RECEIVE CHECKS IN CLARE HALL

Grand Knights and LAMB Directors from five Raleigh Councils presented checks to 10 agencies serving the intellectually handicapped in Raleigh at a breakfast hosted by All Saints Council in Clare Hall Saturday, Feb. 19.

Representatives from Fr. Price Council 2546, St. Raphael the Archangel Council 9880, Our Lady of Lourdes Council 12025 and St. Luke the Evangelist Council 12455 joined host Council 9709 in presenting over \$44,000 in checks. Agencies receiving money included the Autism Society of North Carolina (Wake County Chapter), The Arc of Wake County, Community Partnerships, Inc.; the Frankie Lemmon School and Developmental Center, c/o Harris Creek Elementary School, Hilltop Home, Learning Together, Inc.; the Tammy Lynn Center for Developmental Disabilities and Triangle Downs Syndrome.

Raleigh Councils have been pooling their resources for the past few years to ensure a

FOR THE FIRST DEGREE KNIGHT . . . TAX DEDUCTIONS

The Internal Revenue Service (IRS) allows individuals performing volunteer work to deduct some amounts paid for services performed for a qualified charitable organization that are unreimbursed and directly connected with the services performed. Volunteer work performed in conjunction with the Knights of Columbus qualifies under the IRS definition.

Specifically, you can deduct unreimbursed out-of-pocket expenses such as the cost of gas and oil that are directly related to the use of your vehicle in giving services to a charitable organization. You cannot deduct general repair or maintenance expenses, depreciation, registration fees or the costs of tires or insurance. If you do not wish to keep track of actual expenses incurred, you can claim a deduction of \$0.14 per mile when you use your vehicle for volunteer work or commute back and forth to the site at which the volunteer work is performed. You can also deduct parking fees and tolls whether you claim actual expenses or the standard mileage rate.

You cannot deduct actual expenses or mileage incurred from driving back and forth to meetings or seminars that do not involve direct volunteer service to a qualified charitable organization. As an example, you cannot deduct actual expenses or the mileage you incur from going to a regular Council business meeting, but you can deduct the expense or the mileage if you drive to the Church parking lot to participate in the Council's quarterly Adopt-A-Highway trash pick ups.

You must keep a written record of your vehicle expenses or mileage driven. That record will be accepted by the Internal Revenue Service provided it has the name(s) of the organization(s) for which you worked and the date each time you used your vehicle for a charitable purpose.

The deduction is entered as a cash donation on Line 16 of Schedule A on your tax return.

STATE VACATION RAFFLE TICKET SALES TOP 400

As of March 6, Council 9709 had sold a total of 420 State Vacation Raffle Tickets, including some 41 sold at the Membership Blitz/Pancake Breakfast held in Clare Hall on Sunday, March 6, by Brothers Mike Cichoracki and Frank Sola.

There are still some 473 tickets in Knights' hands and money and stubs or unsold tickets need to be turned in by April 15. So far, seven tickets will be counted as lost. State issued All Saints Council 800 tickets after the Council managed to sell 685 last year.

The Council keeps \$2.50 for every \$5 ticket it sells, and the Council budgeted revenue of \$3,000 from the ticket sales for fraternal year 2010-2011. From all indications the Council will beat that revenue projection handily.

Council officers have selected Brother Halterman as March's Knight of the Month for contributing some 314 volunteer hours working for the Catholic Parish Outreach (CPO) in calendar year 2010. The following is a short biography of Brother Tony submitted by his sister, Mary McReynolds:

"Tony has been a Knight since he was 18 years old. Our father was a convert to Catholicism and joined the Knights while we were in elementary school, so it was natural that Tony would join when he was old enough. He was a member of the Immaculate Lady Council 5208 at Sacred Heart Church in Glyndon, Md., until he moved to Raleigh in 2006 and joined the All Saints Council. Tony was always very active in the Knights often working along side our father at Bull Roasts, Spaghetti Dinners, Oyster Roasts, and Operation LAMB. Tony was part of the Knights Honor Guard when Pope John Paul II visited Washington, D.C., Oct. 6-7, 1979.

"Tony worked for many years at Sacred Heart Catholic Church and School as part of maintenance. The teachers and children at the school were very fond of him as he would often retrieve balls from the school roof, comfort a crying child and help

the teachers hang things or repair things in their classrooms. One year the eighth grade class was asked to write a composition about someone in their life that they admired. An eighth grade boy wrote about Tony. The boy won first place in the contest.

"Tony lives with me and our dog Winston and two cats, Gus and Daisy Marie. He volunteers twice a week (Tuesdays and Thursdays) at CPO and he really enjoys it. Tony is also active in the Seniors Club at St. Francis. Tony has a nephew, Matthew, and a niece, Heather, who also live in Raleigh."

DISTRICT #9 2ND DEGREE TEAM ADVANCES 10

The District #9 2nd Degree team, made up entirely of Council 9709 members, conducted a 2nd Degree Ceremony at St. Francis Thursday, March 3, for 10 Knights representing four area Councils.

FAMILY FRATERNAL BENEFIT PROGRAM

Providing more for those you love.

The Knights of Columbus Family Fraternal Benefit Program makes available to eligible family members seven distinct types of assistance. To be eligible, the member must be in good standing with his Council and either he or his wife must be insured under a KofC certificate requiring an annual premium of at least \$150 or providing at least \$5,000 permanent life insurance coverage.

The Order's various life insurance plans are available through Field Agents for a healthy child, but what about a physically challenged or mentally impaired child? The Order offers three options. First, a \$5,000 life insurance plan, at *standard rates*, for a member's uninsurable or rated newborn child, provided the application is made before the child is 61 days old. Second, a \$5,000 life insurance plan, at *a rated premium*, for a member's uninsurable child between the ages of 60 days and 18 years. And third, up to \$5,000 of life insurance at *standard rates* for a mentally impaired child, otherwise in good health, between the ages of 3-18 years. To be eligible for any of these three benefits, the child's brothers and sisters, who have not been denied insurance, must be insured under an individual KofC certificate.

The Knights of Columbus also provides a \$1,500 death benefit to the family when a child dies less than 61 days after birth and a \$750 death benefit to the family when a child is stillborn at least 20 weeks after conception. Note that while the Order affirms that life begins at conception, the benefit requires a certified death certificate for the stillborn child, which is only issued under law after 20 weeks of conception.

The Order also has an Orphan Fraternal Benefit Program for children of eligible families who lose both parents. An Orphan Fraternal Benefit of \$80 per month is paid to support an eligible orphan until he or she reaches age 19, graduates from high school, enters the military, marries, discontinues KofC insurance or no longer attends school, except in the case of a disabling illness. If the orphan attends college or vocational/technical school full-time, the benefit continues until age 23. The child may also be eligible for up to \$1,750 each year in educational grants. These grants are based on financial need and are limited to a maximum of \$7,000 over a four-year period.

COUNCIL 9709 DONATES 200 BAGS AND \$430 TO FOOD FOR FAMILIES

All Saints Council 9709 donated some 200 bags of groceries (or frozen turkeys) as well as \$430 in cash and checks at four food drives conducted at St. Francis of Assisi Catholic Community during fraternal year 2010-2011. The Council reported these donations to the State Council under the Food for Families Program March 1.

State Food for Families Chairman Ray Wycoff has confirmed that Supreme will again offer a monetary contribution to North Carolina food bank programs as long as 35 percent of North Carolina's Councils partcipate. Last fraternal year Supreme contributed some \$10,000 to North Carolina food banks with some \$5,200 going to the Raleigh Diocese and the remainder to the Charlotte Diocese based upon proportionate participation by the State's Councils.

Some 37 Knights donated 63 bags of groceries and \$75 to the Catholic Parish Outreach food drive over the weekends of Feb. 19-20 and 26-27.

Some 27 Knights donated 34 frozen turkeys and checks totaling \$75 to the St. Francis annual frozen turkey drive Nov. 15-18. The Council's turkeys as well as 62 others donated by some 14 other Ministries were distributed to families through Our Lady of the Rosary Church in Louisburg, Passage Home, St. Francis Feeds, Catholic Parish Outreach and the Inter-Faith Food Shuttle. In addition a number of families from St. Francis experiencing hard times received turkeys from this drive.

Some 33 Knights donated 70 bags of groceries and \$280 in cash to the St. Francis Feed-A-Family food drive for Catholic Parish Outreach over the weekends of Sept. 25-26 and Oct. 2-3.

Some 16 Knights dropped off 33 bags of food for the Migrant Ministry Food Drive at St. Francis over the weekend of July 24-25, 2010.

Due to the number of food drives conducted by Church ministries at St. Francis of Assisi Catholic Church, Council 9709 does not conduct its own food drives. Rather, the Council reports what its members donate individually to these food drives.
