COUNCIL WELCOMES THREE INTO THE ORDER

The All Saints Council 9709 1st Degree Team initiated three new Knights into the Order at the start of the April 5 business meeting. Congratulations and welcome to Brothers John Bauman of Council 10910 in Chapel Hill, Mike Pfauth of Council 9709 and Boniface Sebikali of Council 9549 in Hillsborough!

Brother Mike Pfauth puts the Council back on track to meet the requirements for Star Council this fraternal year. The Supremeassigned goal is 15, and although Brother Mike joining means the Council still needs another 14 new recruits for the fraternal year, All Saints Council has demonstrated in the past an ability to overcome the odds. The Council had already recruited 18 new Knights this year, but also suspended 18 for non-payment of dues.

Council 9709 has a number of potential new candidates who have expressed an interest in joining or for more information. The Council will likely be holding 1st Degree ceremonies in May and June. All Saints Council has added over 60 new members in the past five years, and membership in the Council now stands at 225.

COUNCIL SUBMITS AWARD NOMINATIONS TO STATE

Council officers have nominated Brother Tony Anello as the Council's Golden Knight of the Year, Brother Mike Supianoski as Knight of the Year, Brother Shawn and Mary Beth Bayle as Family of the Year and Brother Diego Ortiz as Rookie of the Year for the State competition. Brother Anello was selected primarily for spearheading the Council's efforts in forming and certifying the District #9 2nd Degree Team, all of whose members come from Council 9709. Brother Supianoski was selected for his record number of shifts worked at the RBC Center and during Operation LAMB as well as a host of other activities for which he has volunteered. Brother Bayle and wife Mary Beth were selected as Family of the Year for their joint work organizing and executing the Council barbecue, the LAMB breakfast and Membership Blitz pancake breakfasts. Brother Ortiz was selected for his single-handed effort in putting together a viable display panel for the Council. Congratulations to all!

The Council's Service Program Awards submissions included entries in Church, Community, Council, Youth, Membership and Pro-Life. The Church submission was for the Council's participation in the Refund Support Vocations Program (RSVP). Under Community the Council submitted its hosting of the annual Operation LAMB awards breakfast held Feb. 19. The Youth Award submission was for the Council's support of Catholic education, including the \$1,000 Cardinal Gibbons High School scholarship awarded this year as well as the \$500 grants provided to The Franciscan School and Preschool. The Membership submission was for the two pancake breakfasts run by the Council to attract new members to the Council. Lastly, the Pro-Life submission was for the Council's participation in both the North Carolina and National Marches for Life.

In addition, the Council submitted its newsletter into the annual newsletter competition as well as a scrapbook, which is required for consideration for the State Deputy's Award. The scrapbook was put together courtesy of Carol Ware. Thanks again, Carol!

FOR THE FIRST DEGREE KNIGHT . . . DUES

The Council's annual dues notices will be sent out via e-mail in May. If necessary, follow-up notices will be sent out to members by mail if there is no response to the e-mail request. Please bring your dues checks to the June or July business meetings and save both the Council and yourself the cost of postage.

Brother Knights of Council 9709 pay annual dues of \$28, an amount that has not increased in years. Of that money, some \$11.50 is dedicated to fixed costs mandated by Supreme and State. Supreme assesses every Council \$1.75 per member twice annually in July and January to meet the operating expenses of the Supreme Council. State sends a bill for \$3 per member in September and February to cover operating expenses of the State Council. In addition, each Council is assessed \$.50 twice annually by Supreme in October and April for the Catholic Advertising Fund, which is used to pay for ads in general interest publications in the United States and Canada that help bring many non-Catholics into the Church. Lastly, Supreme assesses each Council \$1 per member once per year for liability insurance.

The Council has 14 Honorary Life members, who are not assessed dues. Honorary Life members are Knights who have been with the Order for 50 consecutive years or who have been members for 25 consecutive years and are 70 years old. Priests are automatically treated as Honorary Life members. The Council also has six inactive members, who are non-dues paying members who no longer participate in the Council but still have KofC insurance policies in force.

Knights who cannot afford to pay dues are excused by the Grand Knight on a case-by-case basis. Council 9709's 204 full dues paying members provide a revenue stream of \$5,712 to the Council, of which some \$2,346 is already allocated to fixed costs mandated by Supreme and State. That leaves some \$3,366 for discretionary use by the Council. And, don't forget to add \$3.65 to your check for the Penny Per Day Per Knight program! While the contribution is totally voluntary, the need for contributions has never been greater. More on that program in the next newsletter.

OPERATION LAMB BLOWS COUNCIL AWAY

Some 43 Knights and family members braved gale force winds Saturday but enjoyed sunny, pleasant weather Sunday to collect some \$5,715.49 for Operation LAMB.

Of the 80 slots available at the Morrisville Sam's Club, Morrisville Walmart and Kroger on Creedmoor, Knights and family members had only signed up for 62 of them. Some 18 went vacant, mostly those in the evening hours. Brother Tom DuPree worked a total of five shifts during the weekend. Brothers Dick Bridges, Mike Evans and Ralph Guenther worked three shifts each, and 10 Knights and one spouse, Terry Donaghy, worked a total of two shifts each.

The weekend's donations bring the Council's total collection for calendar year 2011 to \$5,880.49, which includes the \$165 collected at the O'Charley's pancake breakfast Jan. 22.

Last year the Council collected a total of \$27,745.78. This year's goal, assuming a three percent increase over last year, will be \$28,578.

Operation LAMB will continue the weekend of April 15-17, and there are plenty of slots available for volunteers on the Council website. Breaking up the spring drive on different weekends was necessitated by store availability.

Cameron also survived a determined challege from fellow Parishioner Cameron Stutts at the Council-level competition, snatching victory after a tie in regulation and three rounds of sudden-death play.

Brother Judge Jim Brown has been selected Knight of the Month for April because of his recruiting efforts this fraternal year. He was responsible for bringing Brothers Diego Ortiz, Joe Paterniti and Dino Pinelli into the Council so far this year and is still working on a couple more candidates.

Brother Jim is a 4th Degree Knight and is active in the Council and Assembly 778. He was named "Rookie of the Year" for fraternal year 2009-2010. He and wife Alice of 45 years are regulars at the monthly Social Gatherings as well as other Knights activities. He is also a member of the Ancient Order of Hibernians of Wake County.

Brother Jim is a retired Federal Administration Law Judge. He had a 37-year career as a trial lawyer with the U.S. Department of Justice in Washington, D.C., as well as private firms in Massachusetts and Maryland prior to being appointed a Federal Administrative Law Judge in Raleigh in June 1995, where he served until retirement in 2008.

He is the author of number of books, including his latest endeavor, <u>Reflections of a Poetic Judge</u> as well as a novel titled <u>Will</u>

BLOOD DRIVE NETS 158 UNITS

The Council-sponsored Blood Drive held Saturday, March 26, netted a total of 158 units of blood for the American Red Cross. With 22 double-red donors, that means that there were some 136 total donors.

There were a total of 175 potential donors who signed up to donate, of which 163 actually made it to Clare Hall. There were also another 22 walk-ins who volunteered the day of the drive. The announced goal had been for 250 donors. The September 2010 drive collected 151 units of blood against a goal of 125 units of blood.

Many thanks go to The Franciscan School seventh and eighth graders who volunteered to help out at the drive. The Council also presented \$25 Barnes and Noble gift cards April 4 at The Franciscan School's daily morning prayer service to the winners of a poster and essay contest. Congratulations to Abby Doyle, who won first place in the poster contest; and Emma

Longley, who took second place honors. Daniel Todd won first prize in the essay contest. All winners are seventh graders at TFS.

Council 9709 supports two blood drives each fraternal year for the American Red Cross, usually the last Saturdays in September and March.

The Council reports the total units of blood donated by its membership on its Annual Survey of Fraternal Activity to Supreme. This past calendar year the Council reported that 20 Brother Knights donated the equivalent of 63 units of blood, another record for the Council.

RBC CENTER BUSTS BUDGET PROJECTIONS

Payments and tips from the RBC Center for the first 14 events the Council has worked during the 2010-2011 season total \$3,718.84, far exceeding the \$3,000 of revenue the Council projected in its budget for this fraternal year. That total includes a payment of \$200.52 from the Durham Bulls Athletic Park Centerplate for working a beer cart at the Miranda Lambert Concert in October 2010.

NHL All Star Skills Competition and Game pulling in some \$997.97, the largest of the 14 payouts so far this year.

The Council is awaiting payment for five other events already worked and will work another seven events TBD this season at the RBC Center.

Through the month of March, some 33 Knights, three spouses and one daughter had pulled at least one shift at the RBC Center. Brothers Mike Supianoski and Mike Wrzesien have each volunteered 10 times, and Brother Ralph Guenther eight times. There are still five events remaining for the 2010-2011 season, unless the Hurricanes make the playoffs. All of the remaining events are rated "C" or "D," which means that they will be less labor-intensive than a regular season hockey game. There's a Josh Grobin Concert on June 1, Sesame Street Live on June 3 and June 5, a Katy Perry Concert on June 14 and a Cirque du Soleil performance on July 7. "For any Knight who has contemplated working an RBC Center event, working one of these events would be a good and relatively painless introduction," said Brother Mike Wrzesien, the Council's RBC Center coordinator.

The revenue received from the RBC Center goes into the Council's General Fund. This revenue and the revenue realized from the sale of State Vacation Raffle Tickets enable the Council to fund a variety of charitable projects during the year. Money generated by the annual barbecue, the other major source of revenue for the Council, is earmarked for supporting Catholic education.
