

## **COUNCIL FINDS VAN FOR USO OF NORTH CAROLINA**

Thanks to the generosity of Brother Jim Falanga, All Saints Council 9709 was able to satisfy a key need of the USO of North Carolina. Brother Falanga donated his 1995 Ford Aerostar van with 79,000 miles on it to North Carolina USO Director Connie Inggs in the Airport Administration Parking Lot of the RDU International Airport on Thursday, May 24.

"I'd like to thank personally Jim Falanga as well as acknowledge the efforts to satisfy this need of the USO of North Carolina by Knights of Columbus Council 9709," said Connie Inggs. "We will be able to provide more effectively for our men and women in uniform serving in North Carolina as a result of your dedication and generosity."

Brother Ralph Guenther, USO coordinator for the Council, identified the USO's need for the van earlier this year, and preparations were underway to appeal to other Councils in the Raleigh area and beyond for cash donations to purchase a used van.

The USO of North Carolina served over 400,000 service members and their families last year at centers in Charlotte, Jacksonville, Fort Bragg and Raleigh. The USO also maintains satellite offices at the New Bern Airport and Seymour Johnson Air Force Base. The USO had been using volunteers' vehicles to transport food, drinks and equipment to these outlying locations, but this arrangement was unfair and untenable in the longterm.

Besides helping the USO of North Carolina and his Council, Brother Falanga will also get a tax deduction on his income tax return for 2012 for having donated the van.

# **COUNCIL APPROVES \$22,960 BUDGET FOR FRATERNAL YEAR 2012-13**

Attendees at the July 3 business meeting approved the Council's \$22.960 budget for fraternal year 2012-13. The budget is structured differently than last fraternal year's budget, and the \$22,960 figure does not include some \$6,000 in pass through items such as monies received and disbursed for the Christmas party. The biggest change is the Council's having to adjust anticipated income due to the loss of the revenue stream from the RBC Center in past years. Last fraternal year's budget was approved for \$38,510, and the year prior to that it was \$41,330.

"Although this budget appears to be less than previous years' budgets, it still represents the Council's commitment to the Order's guiding principle of charity in all its endeavors," said new Grand Knight Shawn Bayle. "Council officers were also very conservative in their estimates of anticipated revenue, so we may be able to do considerably more given the right circumstances, particularly with success in the new fundraising activities planned for next year."

The budget fully funds Council continuing commitments to Room at the Inn (\$2,000), RSVP (\$1,500) and the Benefit for Life Gala (\$1,500). It also includes a line item of \$2,500 to support the renovation the kitchen in Clare Hall.

Primary sources of revenue include the concession stand at the Durham Bulls Athletic Park (\$2,500), an Art Auction (\$1,500), a golf outing (\$2,000), a dinner theater project (\$1,800) and hosting the Chicago-based Catholic play "Late Night Catechism" (\$4,000).

# FOR THE FIRST DEGREE KNIGHT . . . PPDPK



Financial Secretary Dennis Kelleher sent out annual dues notices via e-mail June 15. If necessary, follow-up notices will be sent out to members by mail if there is no response to the e-mail request. If you have not already done so, please bring your dues checks to the August business meeting and save both the Council and yourself the cost of postage. And, don't forget to think about a voluntary contribution of \$3.65 on top of the \$28 in dues to cover the State's Penny-Per-Day-Per-Knight program!

Your dues notice will include a line for a voluntary \$3.65 contribution to this fund. This past fraternal year, All Saints Council sent some \$800 to State for this fund, up from the \$611 sent for fraternal year 2010-11. If all members of the Council would contribute this year, the Council would again be sending about \$800.

As of June 30, some 36 Council members had responded to the initial e-mail request for dues. Effective July 1, Council members can also pay their dues via credit card online. The link to the Council "storefront" is

on the Council website.

At the May 1999 State Convention, delegates passed a resolution establishing a Catholic Charities Fund that would be supported by a voluntary "penny per day per Knight" donation from every Knight in North Carolina. Contributions are used by the State's two Bishops to support Parishes in need, especially during natural or manmade disasters. Monies collected are intended to be used in the year they are collected under the premise that there is always a need somewhere in North Carolina. Delegates to the 1999 Convention felt that it was more practical to establish an existing fund to support the Bishops than appeal for assistance to all Councils on an as-needed basis.

Since the program's inception, the State Council has also made contributions internationally at the Bishops' request. For example, the State made a \$500 contribution in support of Haiti in the wake of the earthquake that ravaged that nation in January 2010.



## **COUNCIL CLEANS UP LEESVILLE ROAD FOR ANOTHER YEAR**



Eight Brother Knights picked up nine bags of trash and three bags of recyclables Saturday morning, June 9, to complete another fraternal year of participation in North Carolina Department of Transportation's (NCDOT) Adopt-A-Highway Program. The Council has been picking up trash along the stretch of Leesville Road from the Citgo Station to the Durham County line since January 2001.

For fraternal year 2011-2012, some 16 Council members picked up a total of 29 orange bags of trash and 11 blue bags of recyclables during the quarterly pick ups in September 2011, December 2011, March 2012 and June 2012. Special thanks go to Council Coordinator Brother John Moster and Brother Mike Supianoski who worked each of the four quarterly pick ups. Thanks as well to Brothers Shawn

Bayle, Dick Bridges\*, Jerry Cucurullo, Don Donaghy\*, Tom DuPree, Mike Evans, Ralph Guenther\*\*, Tru Hall\*, Fred Johnson, Larry Mathiot, Mike Pfauth, Ron Price\* and Kent Siefkes. Brother Knights' names marked with an asterisk (\*) worked two of the quarterly pick ups and those with two asterisks (\*\*) worked three.

Brother Moster estimates that some 58 volunteer hours were donated by the 16 Brother Knights who participated in the program. Depending on the number of individuals working a particular pick up, it takes an average of about two hours to collect the debris along Leesville Road.

All Saints Council 9709 completed 10 years of service in the Adopt-A-Highway Program as of Jan. 1, 2011, and the signs marking the limits of the Council's responsibility on Leesville Road now sport 10-year decals marking that milestone.

According to the NCDOT website, the department's Adopt-A-Highway is the second largest anti-litter organization in the nation, with more than 6,000 groups having adopted more than 13,000 miles of state-maintained roads. NCDOT estimates that these groups have saved the State more than \$30 million in clean up costs since the program's inception.
