The Diocese will sponsor three major events Saturday, Jan. 19. There will be a Diocesan Mass for Life beginning at 8 a.m. at St. Joseph Catholic Church celebrated by Bishop Michael F. Burbidge. Fourth Degree Knights are encouraged to wear their regalia and participate in the Honor Guard. The Mass will be followed by the 14th Annual Prayer Breakfast for Life at the North Raleigh Hilton beginning at 9:30 a.m. To register for the breakfast, interested Knights can call 1-800-392-6275 or go online at http://ncrtl.org/prayer-breakfast-for-life, where they can get more information on the Prayer Breakfast and Rally, including speaker biographies.

The highlight of the day will be the Rally and March for Life beginning at 1 p.m. in Nash Square in downtown Raleigh (Hargett and McDowell Streets). Bishop Burbidge will speak at the Rally. 4th Degree Knights in regalia will lead the march to the State Capital, and all other members of Council 9709 are encouraged to march with the Council banner.

The following weekend, a contingent from All Saints Council 9709 will travel to Washington, D.C., for the North Carolina Mass for Life beginning at 11:30 a.m. at the Basilica of the Immaculate Conception where Bishop Burbidge will celebrate Mass and Charlotte Diocese's Bishop Peter Jugis will be the homilist. The Brothers will then participate in the 40th Annual National March for Life on the Capitol Mall beginning at 1 p.m. Council attendees will stay overnight at Holy Name College where they will also have the opportunity to meet with two of the three seminarians being supported by the Council's participation in the Refund Vocations Support Program (RSVP). Each of the seminarians will receive a check from the Council for \$500 to assist with living expenses during the course of their studies. FOR THE FIRST DEGREE KNIGHT . . . VOLUNTEER TAX DEDUCTIONS

The Internal Revenue Service (IRS) allows individuals performing volunteer work to deduct some amounts paid in providing services to a qualified charitable organization. A deduction must be unreimbursed, directly connected with the services provided and incurred only because of the services given and not personal, living or family-related expenses. Volunteer work performed in conjunction with the Knights of Columbus qualifies under the IRS definition.



Specifically, you can deduct unreimbursed out-of-pocket expenses such as the cost of gas and oil that are directly related to the use of your vehicle in giving services to a charitable organization. You cannot deduct general repair or maintenance expenses, depreciation, registration fees or the costs of tires or insurance. If you do not wish to keep track of actual expenses incurred, you can claim a deduction of \$.14 per mile that you use your vehicle for volunteer work or commute back and forth to the site at which the volunteer work is performed. You can also deduct parking fees and tolls whether you claim actual expenses or the standard mileage rate.

You cannot deduct actual expenses or mileage incurred from driving back and forth to meetings or seminars that do not involve direct volunteer service to a qualified charitable organization. As an example, you cannot deduct actual expenses or the mileage you incur from going to a regular Council business meeting, but you can deduct those expense or the mileage if you drive to the Church parking lot to participate in the Council's quarterly Adopt-A-Highway trash pick ups.

You must keep a written record of your vehicle expenses or mileage driven. That record will be accepted by the Internal Revenue Service provided it has the name(s) of the organization(s) for which you worked and the date(s) each time you used your vehicle for a charitable purpose.

The deduction is entered as a cash donation on Line 16 of Schedule A on your tax return.

All Saints Council Youth Director Brother Mike Wrzesien presented Kirsten Keleher a Merriam-Webster dictionary for winning The Franciscan School's (TFS) 2013 spelling bee, held in the school library, Wednesday, Dec. 12. Kirsten is a seventh grader at TFS, and she also won a one-year online subscription to Encyclopedia Britannica and a free semester of an online world language course from Middlebury University Interactive Languages. She is now eligible to compete at the regional level to be held at McKimmon Convention Center at North Carolina State University Feb. 23 for a chance to advance to the Scripps National Spelling Bee competition in Washington, D.C.

TFS conducted the preliminary rounds for the spelling bee by class for 3rd through 8th graders, and the top two finishers in each grade advanced to the final. Congratulations to 3rd graders James Marshall and Wyatt Weber, 4th graders Livia Loverse and Grace Diamond, 5th graders J.J. Malach and Carson

Potts, 6th graders Isabel Daumen and Angelica Rock, 7th graders Kirsten Keleher and Carter Reilly and 8th graders Brooke Connolly and Nathan Schwede for making it to the final round. Fourth grader Grace Diamond was runner up at the bee, and she also won a free semester of an online world language course from Middlebury University Interactive Languages. All participants received a certificate of participation from TFS.

Words were selected from the list provided by Scripps National Spelling Bee. Each round of the competition involved each contestant receiving a word to spell, starting with the youngest in alphabetical order. Words used in 3rd grade competition were used first, and after each round, the next words selected increased in difficulty. If a contestant misspelled his or her word, he/she was asked to remain seated in the competition area. Once only one contestant remained, he/she was given one more word for the championship round. The final contestant had to spell that word correctly to win. This year's competition lasted 16 rounds.

Thanks to Brother Dick Bridges, who did duty as the pronouncer, Brother Mike Wrzesien, who was recorder for the bee, and Brothers Tony Evans, Ralph Guenther and James Powers, who worked as judges for the competition. Deputy Grand Knight Brian Denison also represented the Council at the bee.

This is the second time the Council has supported a TFS spelling bee. The last time the Council sponsored the event was in 2011. No competition was held in 2012.

COUNCIL LOOKING FOR NEW FINANCIAL SECRETARY

WHY I BECAME A FIELD AGENT

My father, who was a Field Agent with the Knights of Columbus for over 20 years, was the one who first suggested I become a Field Agent. At that time, however, I was not interested and went to work for Coca-Cola after graduating from NCSU in 1993.

In 2000 my mother passed away unexpectedly. The response from the Knights of Columbus was overwhelming. At this time I came to realize what my father had been doing for all these years. When I arrived for my mother's wake, a man was standing on the steps of the funeral home and said: "You must be Tim." This Brother Knight went on to tell me that he lived in Providence, R.I., but had driven through the night to come be by my father's side. It was quite moving to hear him speak with passion about what my father had done for him and how much that meant to him. There were many more such stories from other people at that time about what my father had done for others in their time of need. After my mother's passing, everything became much clearer as to why my parents thought I would be a good Field Agent.

Interestingly, my mother had always told me when I was in college that I would eventually become a Field Agent. I should have listened. She said I would marry my wife Alisa the first time she met her, and Alisa and I were just getting to know each other at that point. My father and mother knew me better than anyone and realized well before I did that I have always wanted to help others and work for an organization like the Knights of Columbus. I had always respected my father's diligence in helping others, and my final decision to become a Field Agent suddenly became easy, and I left Coca-Cola after six years. Nowadays I hope to fulfill the obligation Father McGivney set out to provide for all Catholic families. I see my chief purpose with the Knights of Columbus as rendering financial aid to the members, survivors and beneficiaries of Brother Knights in their times of need. Most Knights do not pay much attention to the Order's benefits program when they join, but they should. Whether you become an insurance member or not, I promise as your Field Agent to be there for you.

14 CLEAN UP LEESVILLE ROAD DEC. 15



Some 12 Brother Knights and two daughters of one Knight picked up 12 bags of trash and four bags of recyclables Saturday, Dec. 15, along Leesville Road from the Citgo Station to the Wake County line. All Saints Council 9709 has been conducting quarterly trash pick ups along this route for the past 11 years.

For calendar year 2012, the Council picked up a total of 38 orange bags of trash and 14 blue bags of recyclables along that route. Some 21 Brother Knights, spouses and children over 12 years of age donated a total of about 48 volunteer hours for the quarterly pick ups in 2012.

A special thanks goes to Brother John Moster, who coordinates the activity for the Council. Brothers marked with an asterisk(s) (*) participated in more than one trash pick up.

In 2010 the Council received "10 Year" service decals to mount on the signs at the ends of the trash pick up route. The Council will get "15 Year" service decals in 2015.

Created in 1988, the N.C. Department of Transportation's (NCDOT's) Adopt-A-Highway program is a volunteer-driven, clean up organization committed to reducing roadside litter and keeping North Carolina's highways clean. Adopt-A-Highway volunteers have saved taxpayers approximately \$4 million annually in roadside clean up costs. North Carolina has one of the largest anti-litter programs in the nation with 6,000 participating groups and 120,000 volunteers statewide. These volunteers have adopted 12,000 miles of state-maintained roadsides, according to the NCDOT website.

COUNCIL COLLECTS \$18,640.59 FOR OPERATION LAMB IN 2012

Brother Ralph Guenther collected \$74 for Operation LAMB Friday, Dec. 28, outside the ABC Store in the Stonehenge Shopping Center. That amount plus year-end personal donations from 18 Council members of \$1,880 brings the Council's collection for the intellectually handicapped for calendar year 2012 to a total of \$18,640.59. The Council's State-set goal for 2012 was \$19,892. For 2011 the Council collected a total of \$19,313.09 in donations, the fourth highest of any Council in North Carolina.



LAMB Coordinator Brother Tim Stevens thanked the 49 Knights and 12 family members and friends of the Council who worked at least one shift this year at the Jan. 8 business meeting.

Some 85 percent of the Council's collection will be distributed locally to agencies within Raleigh that serve the intellectually handicapped. The remaining 15 percent will be distributed by the State Council to agencies operating in areas of North Carolina where no local Knights of Columbus Council exists.

All Saints Council 9709 will consolidate its collection with those of six other Councils in the Raleigh area: Fr. Thomas F. Price Council 2546, St. Raphael the Archangel Council 9880, Our Lady of Lourdes Council 12025, St. Luke the Evangelist Council 12455, Rev. Joseph McNamara, OMI Council 14422 (N. C. State University) and Msgr. James Keaney Council 15551 (St. Joseph's Catholic Church). Agencies that have been invited to provide proposals for funding include: The Arc of Wake County, Frankie Lemmon School, Hilltop Home, Learning Together, Tammy Lynn Center, Triangle Down Syndrome Network, Wake County Chapter, Autism Society of North Carolina; Wake Enterprises, Inc., and special needs teachers at Harris Creek, Hillburn Drive and Lead Mine Elementary Schools The decision as to how much a particular agency receives is made by a committee made up of representatives of each of the Councils based upon needs expressed by the agencies. The final donations to those agencies and any other bonafide applicants will be made in the February-March 2013 time frame.
